- Donor designations to any 501(c)3 nonprofit are honored.
- 10% of the total raised is placed in an endowment from which earnings benefit health and human services. This enables Lenawee Cares to provide additional assistance when needs increase.
- 80% of the total raised is distributed as grants and designations to local nonprofits for services they provide to Lenawee County residents.
- Approximately 10% of the total covers the costs for supplies, marketing and staffing for the campaign and grants process.

## Lenawee Cares

Lenawee Cares was established in 2016 as an annual campaign for the benefit of Lenawee County. The campaign raises nearly \$500,000 average each year. The Lenawee Cares endowment was utilized as a \$50,000 match for the COVID-19 Response Fund created by Lenawee Community Foundation to help during the pandemic and in 2022 to help support the Lenawee Cares grants to local non-profit organizations.

- The focus of Lenawee Cares is to fund health and human services with an emphasis on meeting basic needs.
- The Lenawee Cares Advisory Board conducts the campaign, assesses community needs and makes grant recommendations. Lenawee Community Foundation staff coordinates the process.
- Gifts and pledges made each fall are fully disbursed as collected in the following year to local non-profit organizations serving Lenawee County citizens.
- 100% of gifts stay in Lenawee County, with the exception of donors designating to out-of-county non-profit organizations.
